- Obscene or inappropriate entries will not be accepted and FTC reserves the right to reject any entries for any reason at its sole discretion.
- Each entrant warrants to FTC that his/her entry is original, their wholly owned creation and made without the inclusion of material owned by any third party. Entrants will keep FTC harmless from any claims in relation to their entry alleging that the entry infringes the personal or proprietary right of any other person.
- All entrants hereby license to FTC the use of their entry for display on any FTC-owned or third-party website or other media for publicity purposes and agree to the waiver of their moral rights in respect of the same.
- Only one entry will be accepted per person.
- Closing date for entry will be Monday 1 July 2019. After this date no further entries to the competition will be permitted.
- No responsibility can be accepted for entries not received for whatever reason.
